

COSCO Warranty

LIMITED 5-YEAR WARRANTY. This product is warranted against defective materials or workmanship for 5 years (fabric or vinyl upholstery on seat, back, and tabletops for one year) from the date of original purchase. Proof of purchase is required. **An original receipt is required to validate your warranty.**

Your exclusive remedy for this Warranty is that COSCO will, at its option, provide repair or replacement parts for this product or refund the original purchase price of the product. COSCO reserves the right to discontinue or change fabrics, parts, models, or products, or to make substitutions.
